## **Marketplace Vendor Directions**

The 31st Historic Bellefonte Cruise Marketplace will take place on Saturday, June 15<sup>th</sup>, 2019 on the Centre County Courthouse lawn located in front of the courthouse at 102 S Allegheny St, Bellefonte, PA 16823. Special vendor parking will be located on either side of the courthouse on E. High Street. Since E. High Street at this juncture becomes two one-way streets, it is important to mention that on the day of the cruise, you must enter from the rear of the courthouse and may drive ON THE RIGHT SIDE on this road to access setup and parking. Parking will be in the lot behind the courthouse. You must be set up by 8am, and are not permitted to tear down early. Please keep this in mind when planning your trip to and from Downtown Bellefonte. Below are suggested routes of travel that consider normal cruise weekend traffic and road closures. If you are setting up on Friday, please do not show up before 530 pm because the road will be used for police and courthouse employees and personnel.

# From I-99 North or South; BELLEFONTE EXIT 83

Exit the highway at EXIT 83/BELLEFONTE. Follow exit ramp to the right, and turn right onto ZION ROAD. Follow this straight into town, as ZION ROAD becomes E. BISHOP STREET. Make a left at the traffic light at the intersection of E. BISHOP STREET and S. WILSON STREET. Then, make the second left before Union Cemetery onto E. HIGH STREET. Follow E. HIGH STREET until you come to a stop sign. Here, you may veer to the right, and then straight down the hill on to the continuation of E. HIGH STREET on either side of the courthouse. Please check-in and parking will be behind the courthouse.

#### From Benner Pike

Due to road closures, please take the Benner Pike to Interstate 99 North. Exit the highway at EXIT 83/BELLEFONTE. Follow exit ramp to the right, and turn right onto ZION ROAD. Follow this straight into town, as ZION ROAD becomes E. BISHOP STREET. Make a left at the traffic light at the intersection of E. BISHOP STREET and S. WILSON STREET. Then, make the second left before Union Cemetery onto E. HIGH STREET. Follow E. HIGH STREET until you come to a stop sign. Here, you may veer to the right, and then straight down the hill on to the continuation of E. HIGH STREET on either side of the courthouse. Please check-in and parking will be behind the courthouse.

### From Milesburg/Howard (from US-220 N)

From, US-220 ALT / PA-144 / S. EAGLE VALLEY ROAD toward COUNTRY LANE. Keep straight onto US-220 N ALT / PA-144 S

Take ramp right for PA-144 South / PA-150 South toward Bellefonte / Milesburg
Turn right onto PA-150 / PA-144. Stay on this road through town and past the Hot Dog House on your
right. Make a left onto N. ALLEGHENY STREET right before Capperella Furniture store. Make a left onto
E. LINN STREET. Make a right onto N. WILSON STREET. Follow N. WILSON STREET past the Union
Cemetery, and make a right onto E. HIGH STREET. Follow E. HIGH STREET until you come to a stop sign.
Here, you may veer to the right, then straight down the hill on to the continuation of E. HIGH STREET on
either side of the courthouse. Please check-in and parking will be behind the courthouse.

# From I-80 Bellefonte Exit 161:

From INTERSTATE 80, please exit the highway at EXIT 161/BELLEFONTE to I-99 SOUTH. Exit the highway at EXIT 83/BELLEFONTE and turn right onto PA RT 550. Follow this straight into town, as the road becomes E. BISHOP STREET. Make a left at the traffic light at the intersection of E. BISHOP STREET and

S. WILSON STREET. Then, make the second left before Union Cemetery onto E. HIGH STREET. Follow E. HIGH STREET until you come to a stop sign. Veer to the right, and then straight down the hill on to continuation of E. HIGH STREET on the side of the courthouse. Please check-in with a Bellefonte Cruise Committee Member and be advised that parking will be behind the courthouse in a designated parking lot.
